Data concerning stateless persons in Malta is nearly inexistent. In the 2011 census, some 200 persons were initially recorded as stateless but prior to publication, the NSO cross-checked the data with other administrative sources (such as the national Common Database) and established that all persons initially recorded as stateless during the 2011 Census had a nationality recorded elsewhere. The only other official reference to stateless persons is found in the annual Demographic Review, which is published by the National Statistics Office and comprises the main demographic events for the year as well as other relevant statistics, such as on migration. Since 2008, the Review has included 'Stateless' as a category of persons who have obtained Maltese citizenship through registration or naturalisation. Between 2008 and 2010, 24 stateless individuals are reported to have obtained citizenship this way. The questionnaire for the 2011 census asks the following question: • What is your country of birth? (with the possibility of respondents entering OTHER). If respondents answer NO to the question 'Do you have Maltese citizenship?', they are then asked, 'Do you have any foreign citizenship?' If they also answer NO to this, then there are no further questions on citizenship.
