According to INSEE, the category “stateless” is not foreseen by the Nationality Codes. The French population census considers that all individuals have a nationality. As INSEE cannot code this denomination, it is considered a non-answer (as are references to unknown nationality). The person is either assigned the nationality of their country of birth or INSEE looks up a respondent sharing similar characteristics where nationality is indicated and assigns them this nationality.</p> <p>Official statistics on statelessness relate to the statelessness determination procedure. In 2021, 266 new claims were lodged. A 10.7% decrease in applications was recorded in 2021 compared to 2020. The 2020 figures show another decrease of 9% compared to 2019.</p> <p>Applications submitted by persons from European countries, who formed the majority until 2019, now only represent 36% of overall applications (a stable proportion since 2020). These are still mainly applications from the former Soviet Union, former Yugoslavia and Italy. The share of people from the former Soviet Union and the share of people born in the former Yugoslavia are each just under 10%, as in 2020.</p> <p>The share of applications filed by people from Africa continues to increase as it now accounts for 43% (38% in 2020). The share of applicants from Asia has slightly decreased (20% in 2021 versus 23.2% in 2020). Only two applications were filed by people born in the American continent.</p> <p>Despite a decrease, applications from people of Sahrawi origin still account for the largest number of cases, at around 20% of the total (52 applications). Many of these applicants lawfully reside in Spain, mostly on the grounds of statelessness and in this respect, OFPRA undertakes systematic checks with the Spanish authorities, as it is reported that cases of multiple of statelessness status in different countries are frequent.</p> <p>Applications made by persons claiming Palestinian origin, whether or not they are under the protection of the United Nations Relief and Works Agency for Palestine Refugees in the Middle East (UNRWA), represent 12% (33 applications). These applicants are from the Palestinian Territories, Lebanon, Syria, Saudi Arabia, Libya or, more rarely, were born on the European territory.</p> <p>With a total of 31 cases, persons claiming Mauritanian origin represent the third stream (11.6% of applications).</p> <p>Applications made by people born in Europe, mainly in Italy, Germany, Belgium or France, remain largely lodged by Romani communities, whose descendants have mostly declared their origin as former Yugoslavia.</p> | <p>INSEE: <a href="https://www.insee.fr/fr/information/2416930">https://www.insee.fr/fr/information/2416930</a> (See the file "To understand... Women represent a minority of Asian (30%) and African (25%) applications. In contrast to previous years, they are also a minority of women among applicants from European countries (45%).</p> <p>At the end of 2021, 1,716 people were protected by the French Office for Refugees and Stateless People (OFPRA) as stateless, 34% of whom were women.</p> <p>In 2021, 491 decisions were issued by OFPRA (more than 55% compared to 2020, where 317 decisions were issued), of which 119 were positive.
